





No. of Days in Overdraft during Apr 2025









CLIMATE ACTION

Climate action progression ongoing in April 2025

- 1. Climate Action attended CARO event in Wexford on 2 & 3 April 2025. Day 1 field trip (Coastal Erosion, Solar Farm, Biomethane heated fire station, NbS Drainage, Community Projects). Day 2 conference event (speakers from LAs, CCAC, EPA, GAA, DECC).
- 2. E&M CARO Climate Action meeting of the Border Region (11 April 2025). Business case made by CARO to regularise resources, governance, staffing requirements for CA. Meeting minutes available.
- 3. Meeting of Energy WG (25 April 2025). Agreed to commence 6-month trial of data management tool 'Energy Elephant' from 1 May 2025. Meeting notes available.
- 4. CARO webinar series to build capacity in the whole-of-Council CA team (the Committee), continued with NbS (4 April 2025) and Biodiversity (17 April 2025). Green Public Procurement training available 8 & 15 April 2025 (and again on 13 May 2025).
- 5. Update of the energy graphs required to complete Annual Progress Report on Leitrim County Council Climate Action Plan for 2024. Correction required on fossil fuel consumption between fleet and thermal in buildings. It is proposed to submit the report at the SPC for the Physical Environment in June 2025.
- 6. Decarbonising Zone awareness video funded by Climate Action Works has been finalised and is available on Climate Action <u>DZ subpage</u> of the website
- 7. Leitrim County Council in association with Good Energy Alliance Ireland hosted Lough Allen College in the Chamber on 30 April 2025. Students learned about the structure of the Local Authority, role of the Elected member and CA and the circular economy.
- 8. Members of the Leitrim County Council CA Committee met with community & business leaders from Carrick on Shannon at the Hive on 30 April 2025. To develop out community climate action through the platform of a Sustainable Energy Community ('Carrick-on-Shannon Climate Action'). Further regular engagement is required to build and sustain partnerships in the Decarbonising Zone.
- 9. Appointed Oisin McGann, children author and illustrator to assist judging the Love Where You Live Climate Action competition in May.
- 10. Leitrim County Council District Heating Feasibility study with AECOM Ireland for Lot (i) to proceed to be funded through the Pathfinder project. Lot (ii) to be reviewed on conclusion of Lot (i). Contract documents being prepared in April.
- 11. Did not partner with ATU on Knowledge for Action in Prevention Preparedness (KAPP).

Community Climate Action Programme Fund

Climate Action continue to work with groups in developing their projects and preparing for drawdown of funding in Phase 1.

The date for opening calls for Phase 2 of the CCAP is still to be finalised by DECC, indications are that Strand 1a (cross border collaboration) may not be rolled out in Phase 2.

Climate Action contributed to CCAP survey for Phase 2 on 9 April 2025. Encouraged broadening the scope to include capital for educational projects, consolidating circular economy themes, emphasising the importance of Strand 1a to border counties and the requirement for Community CA Officer contracts to be extended.

ECONOMIC DEVELOPMENT, PLANNING, AND INFRASTRUCTURE

LOCAL ENTERPRISE OFFICE (LEO)

Training, Mentoring & Export

The following courses were ran in April:

- CapCut App Training
- MicroFinance Ireland Loans Information Webinar
- Online Pension & Auto-Enrolment Briefing Session for the Childcare Sector;
- Enhancing Social Media Marketing with AI training
- Small Business Accounts training
- Food Safety Training (FSAI level 1 & 2)
- Digital Marketing Review Clinic.

Assistance is also available on Export related issues and can be booked online free of charge to discuss any issues facing businesses or identifying and managing opportunities available for exporting.

The Student Enterprise National Finals also took place in the Mullingar Park Hotel on the 8th of May. Students from Drumshanbo Vocational School scooped two awards at this year's National Finals for 'Junior Intellectual Property Award' as well as first prize in the overall Junior Category which was an amazing achievement. St. Clare's Comprehensive School, Manorhamilton also placed runner up in the Intermediate Category so well done to everyone involved with this initiative.

All In A Day's Work Programmes & Associated Financial Supports

The "All in A Day's Work" campaign continues to be rolled out on the areas of Lean, Green and Digital supports. There is significant growth in demand for all three supports, in particular the Energy Efficiency Grant (EEG) and Grow Digital (GD) Voucher. The EEG, with up to 75% of eligible costs up to a maximum grant of €10,000 can be supported following the completion of a Green for Business, Green Start or a SEAI Energy Audit. The GD voucher is a grant covering 50% of eligible costs (minimum grant of €500 up to a maximum grant of €5,000) limited to new software subscriptions for a period of 12 and training and configuration of the software.

Atlantic Economic Corridor Update:

Interreg Europe Digital Rural

Preparations are underway for the hosting of the Interregional learning event in Leitrim in October. On Monday 13th October 2025 a national conference will be held in Lough Rynn Castle on the topic of Smart Town and Vilagges. Following this delegate from the Digital Rural project will spend two days in Leitrim attending presentation and site visits for various projects and initiatives.

PEACE Plus: Digital Services Funding

Leitrim County Council are a partner in the recently successful 'DS3 project' under PEACE Plus investment area 2.4 Smart Towns and villages The DS3 Project aims to increase cross border collaboration and co-operation engaging civil and business communities in the adoption of ICT solutions in community service delivery and economic activity, thereby creating more connected and sustainable communities. The project will run from February 2025 to January 2028.

Regional Enterprise Development Fund: Creative Heartlands

Creative Heartlands is in the process of finalising an evaluation under the REDF funding received. A survey was issued to all stakeholders, and a report is being developed. Over 700 people have engaged in training and networking under the programme across 68 events and €85,000 has been invested in equipment.

Mohill RRDF

The painting scheme for the front of premises in the town is now closed for applications. Letters of offer have been issued with works to start on individual buildings in coming weeks and months. This is under the Rural Regeneration Development Fund and will be administered as the capital works enter their final phase.

Northwest Regional Enterprise Plan Implementation

Vision Development/Next REP Development

The 3 Chief Executives from Leitrim/Sligo/Donegal are collaborating together to develop a Northwest Region Vision which will feed into the REP development in 2025. A working group has been established to develop a scope of work to develop this Vision.

West/Northwest Renewable/Wind energy working group

The Northwest Regional Enterprise Plan hosted the DETE Offshore Wind team in Oweninny Wind Farm for a quarterly joint meeting – a forum to ensure all regions are aware/considered in the development of this industry in Ireland

Regional marketing

A collaborative project between the WDC/NW REP is developing a regional marketing tool mapping all of the enterprise elements in the ecosystem, including county strengths in Leitrim. We are hoping to launch this in Q3

ECONOMIC DEVELOPMENT

Broadband/STEM Initiatives

A New Connected Communities Website has been developed for the BCP network, each Centre will have their own page on the website. Three Secondary schools have expressed an interest in the STEM Passport for Inclusion Programme for TY students. A number of National schools are continuing to work with the Dream Space programme through Microsoft. A meeting took place with the AIM Centre to plan Vex Robotics Sessions with the National Schools in Sept 2025.

Digital Strategy

Work has now commenced on the consultation etc for the new strategy with public consultation sessions planned for May.

Leitrim Diaspora

Regular meetings are continuing regarding the execution of the Diaspora Strategy, presently focused on "The Leitrim Gathering" scheduled to take place in May 2025. Promotion of The Leitrim Gathering continued through various means including social media channels, newsletters and attempts to engage local and national press. Preparations were ongoing to collate a pack of materials for all event organisers.

Leitrim County Council Project Development Grant

Engaging with successful applicants to progress projects deemed eligible under this Scheme.

County Promotion

Progress has been made with the Irish Embassy in London along with representatives from a number of neighbouring local authorities with a view to finalising an inter County promotion event for November 2025. Planning meetings are also taking place with the LEO team around the Smart Towns and Village Conference for October this year.

Funding Applications

Applications were submitted under the Building and Land Acquisition Scheme under Town and Village Scheme.

DRCD Funded Schemes

Town and Village Main Scheme remains open for applications until 6th June 2025.

The CLÁR scheme has now opened for funding and is being promoted accordingly, with a closing date of 16th May.

Minister's Visit

On 24th April, Dara Calleary, T.D., Minister for Rural and Community Development visited a total of 15 locations throughout County Leitrim, to perform official openings, a sod turning and to view a number of other projects funded by his department in recent years.

TOURISM

Marketing Campaign

Preparations for the Sustainable Leitrim campaign are ongoing. Scripts are being finalised, filming schedules have been agreed upon, and the campaign schedule is set. The campaign will include radio, PR, TV, and digital components, and will begin in June after the Gathering celebrations.

Visitor Information App

The Tourism team and industry partners are continuing to build profiles and content for the app. Preparations for promoting the app have begun, including social media, digital banners, point-of-sale displays, and training for front-of-house staff to create awareness and encourage as many visitors as possible to download the app.

Festival and Event Grants Update

Claims for St. Patrick's Day events are being processed, and all letters of offer for festivals and events have been issued. Promotion of festivals and events continues.

The Leitrim Gathering

The Tourism team is assisting with the promotion of the Leitrim Gathering through radio, email marketing, and social media.

Tourist Office



Forward Planning

Carrick-on-Shannon Joint Local Area Plan

The Carrick-on-Shannon Joint Local Area Plan (JLAP) was formally made by Leitrim and Roscommon County Councils on 7th April 2025 at their respective Carrick-on-Shannon and Boyle Municipal District meetings. The JLAP will take effect from 19th May 2025.

County Development Plan 2023-2029

Work is nearing completion on the preparation of the Chief Executive's report on progress in realising each of the objectives contained in the County Development Plan.

Heritage

- The *Leitrim Heritage* Plan 2026 2030 Pre-Draft Public Consultation is underway. This is a six-week consultation period which will inform the priority heritage actions in Leitrim to be implemented over the next five years. Public This has been promoted across social media, local newspaper adverts and posters.
- Four episodes have been released of the *Connecting Through Heritage Memory Meitheals* podcast series and a new series of interviews are being planned for a new series.
- The O'Rourke's of Leitrim Project 2025 is underway. The first two elements of the project being developed are an
 illustrated booklet for the general public and an education pack to engage senior primary school students in
 Leitrim with the O'Rourke's story. Project logo and branding guidelines have been developed. Terms of
 Reference have been developed for the short film and Interactive Map elements with contractors invited to
 quote.
- The Community Monument Fund conservation works have been completed at St Mogue's Abbey, Rossinver.
- The Community Monument Fund 2025 has awarded The Old Church of Ireland, Manorhamilton funding to produce a Conservation Management Plan for the site.

Pavement Overlays

- N16 Pavement Overlay Scheme (POS) Manorhamilton to Cornacloy Phase 1 This POS Scheme was completed in 2023, and final Retention has now been paid to the Contractor. Awaiting close out Report from Consultant.
- **N4 Pavement Overlay Scheme Carrick on Shannon** Consultants are currently working on the design and tender documents for this Pavement Overlay Scheme. Consultants are also looking at additional drainage works required due to poor condition of storm drainage. Once detailed drainage design is completed, this pavement overlay scheme will be tendered, subject to TII approval.

Realignment of N16

• Realignment of the N16 at Drummahon – Works on this Realignment Scheme are now complete. Awaiting specialist contractor & Manorhamilton District Engineers office to complete additional residual network works.

N16 HD17 Road Safety Inspections – Works include:

• **Strabrick Junction** – Safety Works at this Junction on the N16 were substantially completed in 2024. To be closed out in 2025

HD15 Road Safety Improvements on N4 - Roundabouts on N4 (Shannon Lodge Roundabout to end of Speed Limits)

TII & Leitrim County Council met onsite to discuss scheme – Leitrim County Council to complete Feasibility & Options report and submit to the TII and once approved a pedestrian and vulnerable road movement survey will be procured and completed. LCC has issued draft of F & O report to the TII for their comment.

Bridge Rehabilitation Works

De-vegetation of Bridges in North & South Leitrim has been completed in preparation for the 2025 proposed Bridge Rehabilitation Programme. Housing Allocations

Applications and Assessments

Applications:

53 new social housing support applications have been accepted to date in 2025. Currently there are 497 approved housing applicants on our waiting list. A further 26 are within the assessment process and 3 applicants have been allocated a property and await appointment.

New Tenancies To date in 2025:

9 new Local Authority/Approved Housing Body (AHB) tenancies have commenced in 2025.

Traveller Accommodation Programme 2025-2029

The new Traveller Accommodation Programme 2025-2029 which came into effect on 1st January 2025 sets out an overall 5-year target for provision of 20 units. At the end of April 2025, the Housing Department have provided 1 no. unit under the Standard Local Authority Housing Scheme.

Housing Grants

A total of 67 Housing Grant Applications have been received to date in 2025. 13 grants have been approved, totalling €80,463.50 in grant funding. 34 applications are under assessment and 20 valid applications are on hand awaiting assessment.

Social Housing Rent Review

A review of almost 1,600 local authority and leasing tenants is nearing completion. Many tenants will see an increase in their rent due to increased incomes.

Housing Capital

Social Housing Delivery

The Housing Capital Team continue to progress the delivery of the annual targets under 'Housing for All'. Progress at 30th April 2025 on the social housing (new housing construction dwellings pipelined for delivery) is as follows:

- Work has commenced on the demolition and re-construction of the recently purchased vacant and semi
 derelict neighbouring 2-bedroom properties on Sean MacDiarmada Street, Manorhamilton into four onebedroom social housing units under the Buy & Renew Scheme.
- Tender documents received are currently being assessed to procure a design team for the proposed construction of a social housing residential development at the Lisnagot Site, Carrick-On-Shannon which was acquired under the Housing for All Land Acquisition Fund.

In addition, works progressed on a number of other 'pipeline delivery projects' to provide additional new social housing supply in 2025 and 2026.

Energy Efficiency

The Energy Efficiency Retrofit Scheme is ongoing with the focus on targeting the houses with the lowest BER rating. In 2025, the Department has set a target of 16 units and progress is on track for delivery by Q4, 2025.

Estate Management Grant Scheme

At the end of April applications had been received from ten Local Authority Estate Residents Associations who will be paid a flat-rate contribution by Leitrim County Council under the scheme during the month of May. The deadline for submission of completed applications has been extended 30th May 2025.

COMMUNITY

Age Friendly Programme

Nursing Home Community Linkage Project Roscommon & Leitrim – Pilot programme - Women's Health Funded project which will run for 18 months in both counties. The aim of the project is to reduce loneliness of residents in public & private nursing homes. The project coordinator will recruit volunteers from community groups to partner with residents. Information briefing sessions with community groups will take place in the Chamber on the 20/5/2025. The coordinator will develop individual action plans with residents, introduce group activities such as physical and cultural programmes and improve digital skills.

National Healthy Ageing Course – Deirdre Lang of HSE in contact with OPC to arrange evaluation of course content for a new nationwide programme the HSE will roll out to Older People. Leitrim OPC provisionally booked to meet Deirdre on 13th of June in Drumshanbo to review course content and incorporate OPC feedback before the programme is launched.

Healthy Ireland

39 volunteers have now attended training for Dementia Friendly Mohill with the HSE. Healthy Ireland along with Sharon Richardson (HSE) attended the Carrick Town Team meeting and have agreed that Carrick will be the next Dementia Friendly town. The committee are forming a subcommittee to start the process. The next town team to be approached will be Manorhamilton.

Three more community events are planned for May. On May 15th Mental Health Irelands Nationwide 'Hello! How are You?' awareness day takes place and Healthy Ireland are organising 'Tea and Tunes' Connect Cafés. The events are running in The Bee Park from 1030-11.30am, and in Breffni FRC from 2.30p-3.30pm. The music circle will be facilitated in Breffni FRC by Kristina Kenny and in Bee Park by Hugh Feely, with the public encouraged to bring their own instruments or come to listen and chat.

On May 23rd Mike Hanrahan from Stocktons Wing will be performing in The Mayflower Drumshanbo for our 'Mayflower Memories' Age Friendly Ireland event. Mike will perform and explain the research project for his PHd – the topic of which is the relationship between music and memories for people with dementia. The event targets people living with dementia, their carers, family and friends. Sharon Richardson from the HSE will also present on Dementia and support available, and Philip Darcy will have his Showband Memorabilia Exhibition there on the evening. The event runs from 6-9pm.

Co-design Hub consultation meetings ran across the county with 24 community groups and active age groups in attendance. The remaining series of community events and workshops will be designed based on feedback from the groups in attendance and an online survey for those who weren't in attendance.

Love Where You Live

Entries for the Love Where You Live Schools Competition closed on 7th April. There was a wonderful response to this year's Climate Action themed competition. Independent judge Oisín McGann along with Leitrim County Council staff will visit the participating primary schools in May for judging.

The 2025 Love Where You Live competition for community and voluntary groups opened for entries on 9th April, deadline for entries is 26th May. This is a joint initiative of Leitrim Public Participation Network and Leitrim County Council. All community and voluntary in Leitrim are encouraged to enter. This years' categories are Green Community, Green Estate, Age Friendly Community, Social Inclusion and Community Achievement. Judging of entries will take place in late June and the Love Where You Live Awards night will take place on 2nd October.

- A First project board for the delivery of the Shannonside Peace Arena project was formed. This includes
 officials from the dept of Rural & Community Development, Dept of Communities NI, funders SEUPB,
 members of SRC committee and staff of Leitrim County Council. The first meeting took place on Friday 25th
 April.

Local Community Safety Partnership (LCSP)

The Policing, Security and Community Safety Act 2024, has commenced. We are currently awaiting the accompanying regulations which will provide a framework for establishing the Local Community Safety Partnership in line with the provisions of the Act.

In accordance with the legislation the membership of the LCSP will be community focused. Statutory services including AGS, HSE, TUSLA and seven local Councillors will be mandated onto the LCSP. Further members will be recruited on local needs.

The Community Safety Fund 2025 is now open with a deadline of the 16th of May 2025; the fund is focused on the redistribution of CAB assets to local community safety initiatives. Attended the Policing and Community Safety Authority Consultation on policing priorities up to 2025- 2028.

Local Authority Integration Team (LAIT)

The Integration Team conducted 4 clinics 2 clinics focused on Beneficiaries of Temporary Protection and one clinic was onsite in Dromahair IPAS and Carraig Accommodation IPAS centre. All clinics were to identifying needs of the residences/families.

5 Offer A Home activations took place in April accommodating 8 people which are Beneficiaries of Temporary Protection.

The Integration Team worked in collaboration with Aremoja Women Group Sligo to deliver 2 parenting in Ireland sessions in Abbey Manor Hotel. One session was held in the afternoon and one in the evening to facilitate parent who were working.



LIBRARY SERVICES



There were 181 new library memberships recorded for April. There were almost 9,500 visits to libraries across the county.

Over the month all libraries were busy with the usual events such as class visits, reading groups, , art & craft sessions, games afternoons/evenings, bridge club etc

Many school classes attended 'Spring into Storytime' Events held across the branch network. Some outreach Storytime sessions were also facilitated by staff. The 'Spring into Storytime' initiative was run across the county with fun and engaging story-times being delivered to young children as part of the national Right to Read Programme.

The third event in the 'Conversations on Books' series took place on 12th April in the Dock Arts Centre. and featured the book Fahrenheit 451 by Ray Bradbury. An afternoon of lively chat was facilitated by library staff.

Cathaoirleach of Leitrim County Council, Cllr. Paddy O'Rourke launched the *'Leitrim Gaelic Games – Reflections and Memories'* exhibition in Ballinamore Library on 12th April. This special event celebrated the rich history and impact of Gaelic Games on our communities here in Leitrim. Through the exhibition boards, various elements of Gaelic Games across the county were highlighted, including the Club scene, LGFA, Hurling, Handball, and Scór. Among the many fascinating photographs were images of the Leitrim team who won the Connacht Championship in 1927, the

team who reached the Connacht Final in 1958, and the victorious team of 1994. All items were sourced from our local studies collection thus showcasing the wealth of information held and available in local studies.

Present at the launch were members of the Leitrim Ladies Team who won the 2024 All Ireland Intermediate Championship and the Kane sisters from Fenagh who were crowned World Wall Ball champions 2024. There was a big attendance, and all had a very enjoyable evening which included refreshments.

There was much excitement and interest on April 24th in Dromahair Library where we welcomed a visit from Minister Dara Calleary, Minister for Social Protection and Minister for Rural and Community Development and the Gaeltacht who officially opened Dromahair Library.
