PRIVACY STATEMENT FOR VIDEOGRAPHY AT THE TURNING VACANT PROPERTIES INTO COSY HOMES EVENT IN THE LANDMARK HOTEL, CARRICK ON SHANNON ON 19TH JUNE 2025.

Who are we?

Leitrim County Council (the Council) is the democratically elected unit of Local Government in County Leitrim and is responsible for providing a range of services to meet the economic, social and cultural needs of the people of our County. In order to provide the most effective and targeted services to meet the needs of the citizens, communities and businesses of County Leitrim we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being offered, information sought may include 'personal data' as defined by the Data Protection Acts and the General Data Protection Regulation (GDPR) and may relate to current, past and future service users; past; current and prospective employees; suppliers; and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect process and use certain types of personal data to comply with regulatory or legislative requirements or to carry out functions in the public interest.

Why do we have a Privacy Statement?

This privacy statement has been created to demonstrate the Council's commitment to you that personal data which you may be required to supply to us, to enable us to provide services, is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, identified and legitimate purposes
- Processed for purposes which we have identified or purposes compatible with the purposes that we have identified.
- Adequate, relevant and limited to what is necessary for the purpose for which it was obtained
- Is collected and processed accurately and kept up to date (where necessary)
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Processed in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

What is the activity referred to in this Privacy Statement?

This statement refers to the processing of personal data in the form of video interviews with Croi Conáithe grantees (the data subject) and attendees at the **Turning Vacant Properties into Cosy Homes** event on 19th June 2025. The interviews and use of the resultant footage will only be carried out and used with the consent of the data subject. Leitrim County Council will use this

footage to promote and raise awareness of the Croi Conáithe grant and other regeneration type promotional activities in the future. Photos of homes will be used with the consent of the data subjects. It should be noted that signage will be erected clearly detailing that videography is taking place at the event. This signage will be displayed in a prominent place/position before any member of the public enters the venue. The MC at the event will make regular announcements that videography is being taken.

What is the basis for making the processing of this personal data lawful?

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in Leitrim County Council in accordance with Article 6(1)(e) of the General Data Protection Regulation, 2016.

Specifically, the lawful basis for the procedures is listed below:

- Section 66 (3) (a) (b) of the Local Government Act 2001 and
- GDPR article 6 (1) (a).
- GDPR article 6 (1) (e).

What categories of personal data is held by Leitrim County Council

The aim of the project is to capture video footage of Croi Conáithe grantees (data subjects) as well as members of the public who are attending event. It is anticipated that the eventual video interviews and video footage of the day will be used to promote and raise awareness of the Croi Conáithe grant, and other regeneration type promotional activities in the future. Photos of homes will be used with the consent of the data subjects as part of the Turning Vacant Properties into Cosy Homes event. It is intended to collect the names of the grantees taking part in the interviews for captions.

Is personal data submitted as part of this activity shared with other organisations?

Data may be shared with the Department of Housing, Local Government and Heritage.

How long is my data kept for?

Video footage will be used for promotional purposes and retained for archive purposes.

Do you need to update your records?

Leitrim County Council must take reasonable steps to ensure that personal data we have about our customers is correct and up to date. In addition, if the data held is found to be inaccurate, you have the right to rectify or correct this. If you find that personal data we have about you is inaccurate or needs to be updated (for instance, you may have changed your name, address, contact details etc) then please contact us so that we can correct it. You can do this by:

When making a request to update your record, please provide evidence to support this- for example a copy of a document containing your new address, utility (Gas, Electricity, Phone) bill etc.

Your rights:

You have the right to obtain confirmation as to whether data concerning you exists, to request access to personal data held about you, to be informed of the content and source of data and check its accuracy.

If the data held by us is found to be inaccurate you have the right to rectify/correct this – see above on how to update your records.

You also, subject to certain conditions being met, have the right to object to or seek restriction of the processing of personal data and to request the erasure of personal data held by the Council. You also have the right to data portability where technically feasible.

Please note that to help protect your privacy, we take steps to verify your identity before granting access to personal data.
