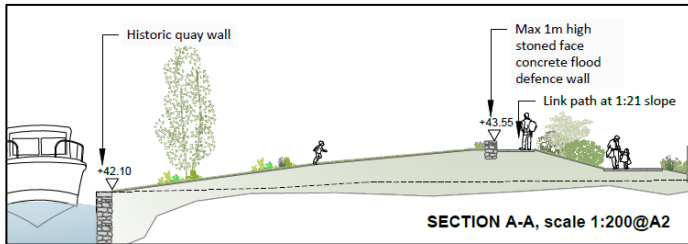

Investigations & Surveys

Site Investigation

IGSL Ltd. have completed all site investigations and groundwater monitoring has been closed out.

Topographical Survey

McDonald Surveys (MCDS) Ltd. have completed all required surveys.

Hydrological and Hydraulic Analysis

Work on scheme hydrology and the hydraulic model of the River Shannon, Ballinamore and Ballyconnel Canal and local tributaries is complete. The Hydrology and Hydraulic Modelling Reports have been updated based on detailed reviews by LCC and OPW. The hydrology report has been finalised, with the hydraulic modelling report currently undergoing a final review.

Stakeholder Engagement/ Public Consultation

The opening public consultation process was undertaken, with responses from this consultation included in the Constraints Study Report. A second Public Consultation was undertaken in early 2025. The content presented at both Public Consultation events is available on the project webpage.

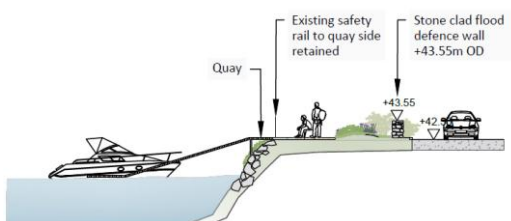
Meetings with landowners are currently progressing with further scheme detail available for discussion.

Environmental/ Archaeological Tasks

Extensive environmental surveys have been undertaken to support assessments as part of the Leitrim Village FRS.

Advanced archaeological investigations have been undertaken, including geophysical surveys of all scheme areas and archaeological test excavations at the site of Leitrim Castle. Reporting for all works has been closed out.

Consultation associated with the Environmental Impact Assessments Scoping has been closed out.

Submission of much of the Draft Environmental Impact Assessment Report (EIAR) for review has been completed. Outstanding chapters of the report and the Natura Impact Statement (NIS) are to be submitted in the coming weeks. The environmental assessments are subject to an ongoing detailed review and update before finalisation of the documentation.

Options Assessment

Options assessment tasks are complete. The proposed scheme for Leitrim Village has now been finalised. Landowner discussions are ongoing with feedback considered in the proposed scheme final details. The options assessment report has undergone further update and review in the last month, with a final report anticipated in the coming weeks.

Approval Process

The next milestone following EIAR review is submitting the Proposed Scheme documentation for project approval gate review. Required documentation includes engineering and environmental reporting deliverables produced to date. Following successful approval, the scheme can progress towards lodging a planning application.

Work Activities Planned for Next Period

Submit final draft Environmental reporting and update EIAR following review.

Key Upcoming Milestones

Finalise the Hydraulic Modelling Report and Options Assessment Report.
