



APPLICATION TO ADD OR REMOVE A HOUSEHOLD OCCUPANT

A Tenant must notify Leitrim County Council of a permanent change in household composition at a Local Authority tenancy. The information provided will assist Housing staff in assessing the request in accordance with the Leitrim County Council Allocations Scheme, the Tenancy Agreement and relevant housing legislation.

- Adding an occupant does not grant them tenancy rights
- Occupants must not be added without Council approval
- The Council may request additional documentation
- Providing false or misleading information may affect your tenancy

This procedure does **not** apply to RAS, HAP and Leasing tenancies to require permission to add/remove occupants, which are governed by their own tenancy agreements and programme arrangements. Any change in household composition in such cases must be notified to the Housing Authority for rent assessment and record purposes, and the necessary updates will be processed in accordance with the applicable scheme requirements.
