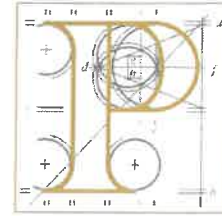


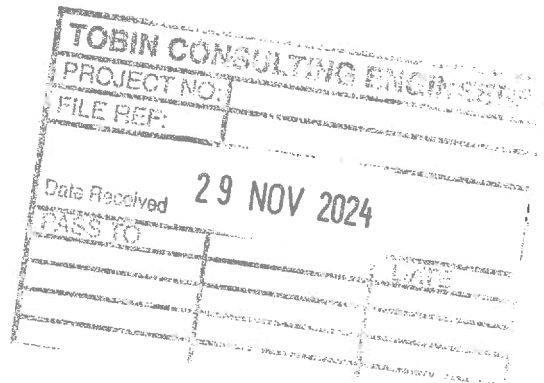

**Re:** Proposed Development of Rossinver Wastewater Treatment Plant and Ancillary Works, Co. Leitrim. Section 177AE Planning Application in the townlands of Gubalaun and Sraud (Conolly).

Dear Sir / Madam,

I have been asked by An Bord Pleanála to refer further to the above-mentioned proposed development which is before the Board for consideration.

Please be advised that the Board, in accordance with section 177AE(5) of the Planning and Development Act, 2000, as amended, hereby requires you to furnish the following further information in relation to the effects of the environment of the proposed development:

1. It is noted that the proposed WWTP does not connect any dwellings or other buildings within the village of Rossinver south of the junction with the R281 or Ballaghmeehan National School. Please provide the reasoning behind the decision to restrict the catchment of the proposed WWTP to the housing on the northern side of the village only.
2. The EPA, in its letter dated 6<sup>th</sup> August 2024, requests clarification on the issue of how the proposed discharge can be regulated under the European Union (Wastewater Discharge) Regulations 2007 to 2020. Please respond and clarify the specific issues raised in the EPA submission.

The further information referred to above should be received no later than **5.30 p.m. on the 10<sup>th</sup> January, 2025.**

Please note that following its examination of any information lodged in response to this request for additional information, the Board will then decide whether or not to invoke its powers under section 177AE(5)(d) of the Planning and Development Act, 2000, as amended, requiring you to publish notice of the furnishing of any additional information and to allow for inspection or purchase of same and the making of further written submissions in relation to same to the Board.
