No. 352 of EC \(Public Participation\) Regulations 2010](#), [Section 34\(1A\) of the Planning Development Act 2000](#) (as amended) and [Section 172\(1\) of the Planning Development Act 2000](#) (as amended), that planning reference number P23/600008 was required to have been accompanied by an Environmental Impact Assessment Report and a Natura Impact Statement.

## **Planning Ref. No. 23/60008**

**Description :** the construction of an intake weir, collection chamber, fish pass, one number sound insulated turbine house with a ridge height of 4.375 m above finished floor level plus buried transfer pipe and electricity cable. An EIAR/Natura Impact Statement has been prepared to accompany the planning application at Shriff, Dromahair, Co. Leitrim, F91 PH97.

The Planning Authority is informing the public that Leitrim County Council **decided to grant permission** for the above development on the **8<sup>th</sup> March 2024**.
