# Introduction **1**

This is a request for a Declaration under Part 1, Section 5 of the Planning and Development Act 2000, as amended, as to whether a development is or is not exempted development. This referral case concerns the question as to whether the construction of a 3-bay single slatted shed, of floor area less than 200m², with lieback area and roofed feed passage at Lisdromrea, Kilnagross, Co. Leitrim constitutes development and if so, whether it is or is not exempted development.

The subject application was received by the Planning Authority on 10<sup>th</sup> of April 2025; further information was sought from the applicant on the 2<sup>nd</sup> of May 2025, and a response was received by the Planning Authority on 9<sup>th</sup> of June 2025.

## **Site Location and Context**

The subject property is located along Local Primary Road L-3432-0 to the northeast of Carrick-on-Shannon.

Land uses in the immediate area comprise of one-off housing and agricultural uses in the form of farm holdings and associated agricultural structures.

The nearest Natura 2000 site is Cuilcagh – Anierin Uplands (Site Code 001403) which lies c.12.6km north of the subject site.

The nearest nationally designated site is Annaghearly Lough proposed Natural Heritage Area (pNHA Site Code: 001402) which is located approximately 2.5km northwest of the subject site.

There are no national monuments proximate to the subject site.

The subject site is not located within any landscapes designated for amenity value in the Leitrim County Development Plan 2023-2029.

### **Planning History**

A planning search revealed no recorded planning history associated with the subject site.

### **Relevant Legislation**

### Planning and Development Act, 2000 (as amended)

### Section 2 Interpretation

Section 2(1) of the Planning and Development Act, 2000 (as amended) provides an interpretation of the following'agriculture', includes horticulture, fruit growing, seed growing, dairy farming, the breeding and keeping of
livestock (including any creature kept for the production of food, wool, skins or fur, or for the purpose of its use in
the farming of land), the training of horses and the rearing bloodstock, the use of land as grazing land, meadow
land, osier land, market gardens and nursery grounds, and "agricultural" shall be construed accordingly; 'use', in
relation to land, does not include the use of the land by the carrying out of any works thereon; 'structure' means
any building, structure, excavation, or other thing constructed or made on, in or under any land, or any part of a
structure so defined; 'works' includes any act or operation of construction, excavation, demolition, extension,
alteration, repair or renewal.

### Section 3 Development

Section 3 (1) In this Act 'development' means, except where the context otherwise requires, the carrying out of any works on, in, or under land or the making of any material change in the use of any structures or other land.

### Section 4 Exempted Development

S. 4.(1) The following shall be exempted developments for the purposes of this Act—

(a) development consisting of the use of any land for the purpose of agriculture and development consisting of the use for that purpose of any building occupied together with land so used;

S.4 (2) (a) The Minister may by regulations provide for any class of development to be exempted development for the purposes of this Act where he or she is of the opinion that—

- (i) by reason of the size, nature or limited effect on its surroundings, of development belonging to that class, the carrying out of such development would not offend against principles of proper planning and sustainable development, or
- (ii) the development is authorised, or is required to be authorised, by or under any enactment (whether the authorisation takes the form of the grant of a licence, consent, approval or any other type of authorisation) where the enactment concerned requires there to be consultation (howsoever described) with members of the public in relation to the proposed development prior to the granting of the authorisation (howsoever described).
- (b) Regulations under paragraph (a) may be subject to conditions and be of general application or apply to such area or place as may be specified in the regulations.
- (c) Regulations under this subsection may, in particular and without prejudice to the generality of paragraph (a), provide, in the case of structures or other land used for a purpose of any specified class, for the use thereof for any other purpose being exempted development for the purposes of this Act.

#### Planning and Development Regulations, 2001 (as amended)

Article 6(1) of the Planning and Development Regulations 2001, as amended, states that:

Subject to article 9, development of a class specified in column 1 of Part 1 of Schedule 2 shall be exempted development for the purposes of the Act, provided that such development complies with the conditions and limitations specified in column 2 of the said Part 1 opposite the mention of that class in the said column 1.

**Article 9(1)** of the Planning and Development Regulations 2001, as amended, identifies restrictions on exemptions. Of relevance in this case would be the following:

- (a) if the carrying out of such development would -
- (i) contravene a condition attached to a permission under the Act or be inconsistent with any use specified in a permission under the Act
- (iii) endanger public safety by reason of traffic hazard or obstruction or road users
- (vi), interfere with the character of a landscape, or a view or prospect of special amenity value or special interest, the preservation of which is an objective of a development plan for the area in which the development is proposed or, pending the variation of a development plan or the making of a new development plan, in the draft variation of the development plan or the draft development plan.

Class 6 of Schedule 2 Part 3 of the Exempted Development –Rural allows for the following exemption:

#### Description of Development:

Works consisting of the provision of a roofed structure for the housing of cattle, sheep, goats, donkeys, horses, deer or rabbits, having a gross floor space not exceeding 200 square metres (whether or not by extension of an existing structure), and any ancillary provision for effluent storage.

#### Conditions and Limitations:

- $1. \ No \ such structure \ shall \ be \ used \ for \ any \ purpose \ other \ than \ the \ purpose \ of \ agriculture.$
- 2. The gross floor space of such structure together with any other such structures situated within the same farmyard complex or within 100 metres of that complex shall not exceed 300 square metres gross floor space in aggregate.
- 3. Effluent storage facilities adequate to serve the structure having regard to its size, use and location shall be constructed in line with Department of Agriculture, Food and Rural Development and Department of the Environment and Local Government requirements and shall have regard to the need to avoid water pollution.
- 4. No such structure shall be situated, and no effluent from such structure shall be stored, within 10 metres of any
- 5. No such structure within 100 metres of any public road shall exceed 8 metres in height.

6. No such structure shall be situated, and no effluent from such structure shall be stored, within 100 metres of any house (other than the house of the person providing the structure) or other residential building or school, hospital, church or building used for public assembly, save with the consent in writing of the owner and, as may be appropriate, the occupier or person in charge thereof.

7. No unpainted metal sheeting shall be used for roofing or on the external finish of the structure.

#### **Assessment**

#### File History

I refer to the earlier planning report dated the 30<sup>th</sup> of April 2025 and the following request for further information as issued to the applicant on the 2<sup>nd</sup> of May 2025. The referrer's response, received on the 9<sup>th</sup> of June 2025, is detailed hereunder.

You are requested to submit an accurate site layout plan, drawn to a scale, of not less than 1:500 (which should be indicated thereon), with the site boundary clearly outlined in red with roads, laneways, entrances, field boundaries, dwellings and all other structures on, adjoining and in the vicinity of the site indicated thereon. The site layout plan should clearly show the location of the proposed slatted shed, lie-back area and roofed feed passage.
 Note: All dimensions given must be accurate.

**Response:** A site layout plan showing the above information has been submitted.

2. Submit floor plans and elevations of the proposed slatted shed, lie-back area and roofed feed passage, which clearly identify the floor areas associated there each. Details to include cross sections, dimensions, height and finishes (both roofing and external finishes), should also be submitted of the proposed slatted shed, lie-back area and roofed feed passage. The dimensions given should be in metric. Details of the finishes to the proposed slatted shed shall include a statement confirming that 'No unpainted metal sheeting shall be used for roofing or on the external finish of the structure'.

**Response:** Floor plan and elevation drawings of the proposed shed have been provided. The stated floor area of the slatted shed is 151.2m<sup>2</sup>. It is stated that 'No unpainted metal sheeting shall be used for roofing or on the external finish of the structure'.

3. Having regard to the conditions and limitations set out in Class 6 of Schedule 2 – Part 3, Exempted Development – Rural of the Planning & Development Regulations 2001 (as amended), it will be necessary to indicate the location of <u>all</u> existing dwellings and other residential structures located within 100m of the proposed shed on the revised site layout plan requested in 1 above <u>and</u> submit the required letters of consent from the owners and, as may be appropriate, the occupiers or persons in charge thereof.

**Response:** A site layout plan showing the above information has been submitted. The nearest dwelling house not in the ownership of the applicant is c. 130m away.

 A detailed breakdown of the <u>sizes and uses</u> of all existing agricultural structures within 100m of the proposed slatted shed is required.

**Response:** It has been confirmed that farm buildings within 100m of the proposed shed are store sheds and are not used for animal housing. It has been stated that there is no animal housing within 100m of the proposed shed.

5. Indicate how you intend to access the slatted shed by clearly identifying the location of the existing/proposed access point on the site layout plan requested in 1 above.

In the event that a new access point onto the public road is proposed, it will be necessary to submit the following;

- (a) Indicate the carriageway width of the public road fronting the site on the site layout plan requested in 1 above.
- (b) Indicate the unobstructed sight visibility available in both directions from the proposed access point.

**Response:** It has been stated that access to the proposed shed is via the existing entrance off the public road. It has been indicated that in excess of 100m sight visibility is available in both directions from this existing access point. It is noted that an old shed is being removed to facilitate a new internal farm road to serve the shed.

#### Referral Question

Having reviewed all of the documents relating to this referral, I consider the question to be based on whether or not the construction of a 3-bay single slatted shed, of floor area less than 200m², with lie-back area and roofed feed passage at Lisdromrea, Kilnagross, Co. Leitrim, constitutes development and whether such development is or is not exempted development.

#### Is or is not development.

In relation to whether the proposed works constitute development, regard is had to Section 3(1) of the Planning and Development Act 2000, as amended, which defines 'development' as comprising of two possible components: "the carrying out of any works on, in, over or under land", or "the making of any material change in the use of any structures or other land".

Section 2(1) of the Act provides an interpretation of 'works' as "the carrying out of any works on, in over, or under land" including "any act or operation of construction, excavation, demolition, extension, alteration, repair or renewal...".

Therefore, the construction of a 3-bay single slatted shed, of floor area less than 200m², with lie-back area and roofed feed passage, is development within the meaning of the Act.

### Is or is not exempted development.

The proposed slatted shed can be considered under Class 6 of Schedule 2 Part 3 of the *Exempted Development –Rural* as set out above.

The applicant has demonstrated that the proposed development satisfies the conditions and limitations set out in Class 6 of Schedule 2 Part 3 of the Planning and Development Regulations 2001 (as amended) – *Exempted Development – Rural.* The development therefore is considered to be development that is exempted development.

### Conclusion

Having carried out a site inspection, examined the submission and reviewed all of the documents relating to this development, along with the relevant legislation, I conclude that the construction of a slatted shed, of floor area 115.2m², at Lisdromrea, Kilnagross, Co. Leitrim, is development and is exempted development. Therefore, I recommend that the referrer be advised that the construction of a slatted shed, of floor area 115.2m², at the subject site <u>is</u> development and <u>is</u> exempted development pursuant to Class 6 of Schedule 2 Part 3 of the Planning and Development Regulations 2001 (as amended) – Exempted Development –Rural.

### **Appropriate Assessment**

The proposal has been assessed having regard to the requirements of the EU Habitats Directive. The proposed development has been screened for Appropriate Assessment (AA), and it has been determined that an AA is not required. See Appropriate Assessment (AA) screening report attached.

### **Environmental Impact Assessment**

Having regard to the limited nature and scale of the proposed development and the fact that the development proposed is not of a development type or class set out in Part 1 or Part 2 of Schedule 5 of the Planning and Development Regulations 2001, as amended, it is concluded that there is no real likelihood of significant effects on the environment arising from the proposed development having regard to the criteria set out in Schedule 7 to the Planning and Development Regulations 2001, as amended. It is therefore concluded that EIA is not required.

#### RECOMMENDATION

I recommend that the Planning Authority issue the following Declaration under Section 5 of the Planning and Development Act 2000 (as amended):

**WHEREAS** as to whether the construction of a 3-bay single slatted shed, of floor area less than 200m<sup>2</sup>, with lieback area and roofed feed passage at Lisdromrea, Kilnagross, Co. Leitrim, is or is not development and whether it is or is not exempted development;

**AND WHEREAS** the said question was referred to Leitrim County Council by Catherine Gilmartin on 10<sup>th</sup> of April 2025;

AND WHEREAS Leitrim County Council, in considering this referral, had regard particularly to –

- (a) Sections 2(1), 3(1) and 4(1) of the Planning and Development Act, 2000, as amended,
- (b) Section 3(1) and 4(2) of the Planning and Development Act, 2000 (as amended)
- (c) Article 6 (1) of the Planning and Development Regulations 2001 (as amended)
- (d) Schedule 2, Part 3, Class 6 of the Planning and Development Regulations 2001 (as amended)

AND WHEREAS Leitrim County Council has concluded that -

- (a) the construction of a 3-bay single slatted shed, of floor area less than 200m², with lie-back area and roofed feed passage at Lisdromrea, Kilnagross, Co. Leitrim is development within the meaning of the Planning and Development Act 2000, as amended; and,
- (b) the construction of a 3-bay single slatted shed, of floor area less than 200m², with lie-back area and roofed feed passage at Lisdromrea, Kilnagross, Co. Leitrim is exempted development pursuant to Schedule 2, Part 3, Class 6 of the Planning and Development Regulations 2001 (as amended).

**NOW THEREFORE** Leitrim County Council, in exercise of the powers conferred on it by Section 5(2)(a) of the Planning and Development Act 2000, as amended, hereby declares that:

The construction of a 3-bay single slatted shed, of floor area less than 200m², with lie-back area and roofed feed passage at Lisdromrea, Kilnagross, Co. Leitrim constitutes development which <u>is</u> exempted development.
