**(Parking Places) Bye-Laws 2022**

**In respect of the Town of Carrick-on-Shannon.**

Leitrim County Council (hereinafter referred to as “the Council”) in exercise of the powers vested on them by Section 36 of the Road Traffic Act, 1994 (No. 7 of 1974) and having consulted with the Commissioner of the Garda Síochána, hereby makes the following Bye-Laws:-“

Short Title/

Citation: 1. - These bye-laws may be cited as the Leitrim County Council (Parking Places) Bye-Laws 2022, in respect of the Town of Carrick-on-Shannon

Commencement: 2. - These Bye-Laws shall come into operation on the 3<sup>rd</sup> Oct 2022.

Area of Application: 3. - These Bye-Laws apply to the area comprising the town of Carrick-on-Shannon in the administrative area of County Leitrim, as delineated in the map attached hereto

Repeals: 4. - The Leitrim County Council Parking Places Bye-Laws 2016 in respect of the town of Carrick-on-Shannon amended by these bye laws.

Interpretation: 5. - In these Bye-Laws:

“Act of 1994” means the Road Traffic Act, 1994 (No. 7 of 1994)

“disabled persons parking bay” means a space intended for the parking of a mechanically propelled vehicle in which is displayed a disabled persons parking permit

“disabled persons permit” means a permit issued under Article 43 of the Regulations of 1997

“the Regulations of 1997” means the Road Traffic (Traffic and Parking) Regulations 1997 (S.I. No. 182 of 1997)

“the Regulations of 1997 (Amended)” means the Road Traffic (Traffic and Parking) (Amendment) Regulations, 1998 (S.I. No 274 of 1998)

“the Regulations of 1998” means the Road Traffic (Traffic and Parking) (Amendment) (No.2) Regulations, 1998 (S.I. No.441 of 1998)

“the Signs Regulations of 1997” means the Road Traffic (Signs) (Amendment) Regulations 1997 (S.I. No. 181 of 1997)

“the Regulations of 1997 (Amended)” means the Road Traffic (Signs) (Amendment) Regulations, 1998 (S.I. No. 273 of 1998)

“business hours” means the period from 8.30 a.m. to 6.30 p.m. on a weekday which is not a holiday

“holiday” means Good Friday or any day that is a Public Holiday for the purposes of the Organisation of Working Time Act, 1997

“Loading bay” means that portion of a road indicated by means of a traffic sign on which, at certain times, a vehicle, other than a goods vehicle being used for loading or unloading, shall not be parked

“Class B vehicle” means a mechanically propelled vehicle for which a class B type driving licence is required.

“parking disc” means a disc or document, or a combination of both, issued by a local authority whether obtained by means of a disc parking machine or otherwise and having marks or symbols capable of indicating the year, date and time when the disc document or combination becomes a valid parking disc

“valid parking disc” means a parking disc which

(a) has been issued by Leitrim County Council

(b) has been perforated or otherwise marked as appropriate to the particular type of parking disc, so as to indicate clearly the year, month, day in the month, hour of the day and (to the nearest following five-minute period) minute of the hour of the commencement of a period of parking of the vehicle in which the parking disc is exhibited in accordance with these Bye-Laws

(c) indicate no other year, month, day, hour or minute and,

(d) indicates that the vehicle is so parked for a period for which it may be parked in a disc parking place in accordance with these bye-laws.

“Resident” means a person who is the occupant of a dwelling and who satisfies the Council that his or her normal dwelling place is situated in a street within the pay-parking area and which dwelling has no access to private parking within the confines of the dwelling place.

“Residents Parking Permit” means a document issued by Leitrim County Council or its agents for the purpose of these bye-laws. This will only be issued to residents who have been in occupation of a dwelling on a full time basis since 2002.

Specification of  
Parking Places:

6. (a) The locations defined in The Leitrim County Council Parking Places Bye-Laws 2022 in respect of the town of Carrick-on-Shannon are the locations within the town of Carrick-on-Shannon where paid parking shall apply based upon the display of a valid parking disc.

(b) The following locations (as delineated on the map attached COS-PBL-001-2022) shall represent the locations within the town of Carrick-on-Shannon where restricted parking shall apply as detailed:

**Main St. Carrick-on-Shannon**

*Commencing from Summerhill junction as far as the Clock Junction.*

Right hand side.

From a point 15m west of Kelly’s shop to a point 21.3m west of said location. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Right hand side.

From a point 7m southwest of corner of Percy Wheelan’s pub to a point 26.3m west of said location. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 5.3m northeast of corner of Tipsy Tailor’s pub to a point 18.2m west of said location, Vehicles that are Class B licensed vehicles are allowed park in this location. Traffic signs as per Figure 4.3.17 (F205) and Figure 5.17.3 (P 051) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 13m west of corner of Ash Aesthetics to a point 69.1m southwest of said location. Traffic signs as per Figure 5.17.13 (RUS020), Figure 5.17.3 (P 051), Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Right hand side.

From a point 4.5m southeast of entrance to Sinn Fein office to a point 18.9m southwest of said location. Traffic signs as per Figure 5.17.6 (RUS 018), Figure 5.17.3 (P 053) and Figure 5.17.16 (F204) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 8.1m north of corner of The Bush Hotel entrance to a point 16.7m southwest of said location. Traffic signs as per Figure 5.17.3 (P 051), Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 6m northwest of corner of Moonstone Jewellers to a point 49.5m southwest of said location. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **St. Georges Terrace**

*Commencing from Clock Junction towards the Dock.*

Left hand side.

From a point 4.5m north of corner of Jigsaw hair salon to a point 19.8m southwest of said location. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 7.1m north of entrance of Red Bank Restaurant to a point 44.7m southwest of said location. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.



Right hand side.

From a point 13.5m north of entrance of Red Bank Restaurant to a point 59m southwest of said location. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Church Lane**

*Commencing at Main St. junction travelling northwest.*

Left hand side.

From a point 6.7m from building line of main street northwest for a distance of 50.2m. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Dublin Rd.**

*Commencing from Main St/Dublin Rd junction travelling southeast.*

Left hand side.

From a point 5.3m south from entrance of Kelly's Shop for 44.7m south eastwards. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Right hand side.

From a point 8.1m north from end gable of Citizens Information building for 20.6m north westwards. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 5.1m southwest from northwest corner of Equity House for 22.3m south eastwards. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

Left hand side.

From a point 43.1m northwest of pedestrian access to Scoil Mhuire for 12m south eastwards. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Leitrim Rd.**

*Commencing from Main St Junction to Link Rd Junction.*

Left hand side.

From a point 8.7m east from gable of Pats Carpets for 26.7m northwards. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Link Rd.**

*Commencing from Leitrim Rd Junction to Priests Lane Junction.*

Right hand side

From a point 14.9m from Leitrim Rd junction, westwards for 45.6m. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Priests Lane**

*Commencing from Main St Junction to Link Rd Junction.*

Right hand side

From a point 14.9m from Leitrim Rd junction, north-westwards for 45.6m. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Bridge St.**

*Commencing from Main St/Bridge St junction (town clock) travelling southwards on Bridge St.*

Right hand side

(1) From a point 44.6m north of Quay Rd junction to a point 10 north of the said junction. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

(2) From a point 17.5m south of Quay Rd junction continuing southward for 38m. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

*Commencing at Main St/Bridge St junction (town clock) travelling southwards on Bridge St.*

Left hand side

(3) From town clock/Main St junction, to a point 20m north of N4 junction (building line of Coffey's) excluding loading bay. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **Quay Rd.**

*Commencing from Quay Rd/Bridge St junction travelling west and north on Quay Rd.*

Right hand side

(1) From a point 12m west of main building line of Bridge St continuing westward for 31m. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

(2) From the northwest boundary of Town Hall site to a point 27m southeast of St Georges Terrace junction, right hand side. Traffic signs as per Figure 5.17.6 (RUS 018) and Figure 5.17.3 (P 053) of the Traffic Signs Manual will be provided.

### **N4 Carrick on Shannon By-pass Road**

*Commencing at N4 By-pass Rd/Bridge St junction travelling eastward.*

Right hand side

From a point 25m east of CIE bus stop to a point 365.8m east of said location, vehicles other than Class B licenced vehicles shall not be allowed park. Traffic signs as per Figure 5.45 and Figure 5.46 (RUS019) of the Traffic Signs Manual will be provided.



### **7 Hour Taxi Stands**

*Located at Main St.*

The areas marked as shown on map attached (COS-PBL-001-2022) at schedule 1 shall be reserved as Taxi Stands between the hours of 00.00 to 07.00. From 7.00 to 00.00 this space will act as a loading/bus set down bay.

### **12 Hour Taxi Stands**

*Located at St Georges Terrace, Bridge St & Main St.*

The areas marked as shown on map attached (COS-PBL-001-2022) at schedule 1 shall be reserved as Taxi Stands between the hours of 19.00 to 07.00. Pay and display parking for private vehicles shall be permitted at these locations between the hours of 8.30 to 18.30 only.

### **24 Hour Taxi Stands**

*Located at Bridge St.*

The areas marked as shown on map attached (COS-PBL-001-2022) at schedule 1 shall be reserved as 24 hour Taxi Stands.

### **E-Car Parking Bays**

*Located at in Flynn's Field Car Park.*

The area marked as shown on map attached (COS-PBL-001-2022) will be reserved for electric cars. Electric cars will only be permitted to be parked in these spaces when they are plugged in and charging.

### **General**

Parking is prohibited in all other areas within the streets named above.

Restrictions

7. (a) This Bye-law shall apply (at locations identified above) during business hours, i.e., from 08:30 to 18:30 from Monday to Saturday, inclusive, except for the locations on the N4 Carrick-on-Shannon Bypass Road outlined in section 6 above where restrictions shall be in place for 24 hours each and every day,  
And at the 12 Hour Taxi Parking Stands as identified above.

(b) A vehicle parked in a Disc Parking Place during business hours shall not be so parked for longer than the period indicated as the maximum parking period for that Disc Parking Place by means of an authorised information plate accompanying traffic sign Number RUS-018 authorised by the Regulations of 1997.

(b) Where a vehicle which had been lawfully parked in a Disc Parking Place is subsequently lawfully parked in another Disc Parking Place, the period of the subsequent parking shall be reduced by a period equal to the period from the time indicated on the disc to the time when the subsequent parking commenced.

(c) Where a vehicle is parked in a Disc Parking Place during business hours a person shall not interfere with a valid parking disc exhibited in the vehicle

(d) A vehicle parked in a Disc Parking Place at a time which is not during business hours shall be removed from the Disc Parking Place when a period of business hours commences, unless at such commencement and during the remainder of the period of parking, a valid parking disc is exhibited in the interior of the vehicle.

(e) A vehicle which had been parked in a Disc Parking Place shall not be parked again in a Disc Parking Place in the public road in which that Disc Parking Place is situated until at least one hour after the vehicle last vacated that Disc Parking Place.

(f) A motor cycle or pedal cycle shall not be parked during business hours in a Disc Parking Place.

**Disc Parking Fee 8.** - The fee for a parking disc shall be €1 per hour

**9.** – (a) A vehicle parked in a Disc Parking Place, during business hours, shall have exhibited in the interior of the vehicle a valid parking disc for the period parked.

(b) The valid parking disc shall be so exhibited in the interior of the vehicle that a person outside the vehicle can ascertain by reference to the perforations or markings when the parking commenced and shall be so exhibited for so long as the vehicle is parked in that Disc Parking Place.

Offences

**10.** - A person who contravenes any part of these Bye-Laws shall be guilty of an offence in accordance with the said Section 36 of the Road Traffic Act 1994.


Exemptions


**11.** - The provisions of these Bye-Laws shall not apply to

- (a) A fire brigade vehicle, an ambulance or a vehicle being used by a member of the Garda Síochána or a member of the Defence Forces in the performance of duty, as such member.
- (b) A vehicle being used in connection with the removal of an obstruction to traffic, the maintenance, improvement or reconstruction of a public road, the provision, alteration or repair of a main drain, pipe or apparatus for the supply of water, oil, gas, electricity or of a telecommunications line or the provision of a traffic sign.
- (c) A vehicle displaying a “disabled person’s permit” parked in an area reserved for such parking.
- (d) A vehicle parked while goods are being loaded in or on to it or unloaded from it, for a period not exceeding thirty minutes from the commencement of the parking.
- (e) A vehicle parked at the edge of a roadway while a passenger is entering or leaving it.
- (f) A vehicle which has been damaged or has broken down, during the period necessary to effect repairs to the vehicle or remove it from the location.
